

EYE OF THE HURRICANE By Bob Greco



Some one hundred years ago, though there was no official truce, roughly 100,000 British and German troops in World War I were involved in unofficial cessations of fighting along the length of the Western Front. The truce started on Christmas Eve, 24 December 1914, when German troops began decorating the area around their trenches in the region of Ypres, Belgium.

The Germans began by placing candles on their trenches and on Christmas trees, then continued the celebration by singing Christmas carols. The British responded by singing carols of their own. The two sides continued by shouting Christmas greetings to each other. Soon thereafter, there were excursions across No Man's Land, where small gifts were exchanged, such as food, tobacco and alcohol, and souvenirs such as buttons and hats.


The artillery in the region fell silent. The truce also provided a breathing spell, allowing recently killed soldiers to be brought back behind their lines by burial parties. Joint services were held. German soldiers of the 134th Saxon Regiment and British soldiers of the Royal Warwickshire Regiment met in No Man's Land on December 26. Troops participated in a sing-along which ended with "Auld Lang Syne," and English, Scots, Irish, Prussians, Wurttenbergers, etc., joined in. It was astounding to

observers, who noted also that "soccer was played that Christmas Day—mostly by men of the same nationality, but in at least three or four places between troops from the opposing armies."

These events of humanity, compassion, and hope took place amid one of the greatest tragedies in the history of mankind. There were over 16 million dead and 20 million wounded, ranking it among the deadliest conflicts in human history. Arguably, all of the tragedy, destruction, death and injury were for no reason discernible by any standard of humanity. The "Great War," the "War to End all Wars," was to lead only to the "Greatest War" of all time less than 25 years later.

On January 1, 1914 our Hamlet celebrated its last New Year as "Mineola Park." It was listed for the last time as "Mineola Park, Hastings Tract" in the Atlas of Nassau County. By 1915, still amid the terrible, obscene losses to humanity caused by the Great War, the Carle Place Water District, the Carle Place School District, the Carle Place Post Office, indeed, the Hamlet of Carle Place would be created within the Town of North Hempstead. Out of those desperate times and world devastation, a community sprang forth.

I wish all of our readers, neighbors, family and friends the very best in health, happiness and the blessings of peace in a community that cares, in the eye of the hurricane.



IT'S THE LAW By Francis X. Moroney, Esq.




As I write this article a real life and death drama is underway in Oakland California, pitting the Children's Hospital at Oakland against the parents of Jahi McMath, a 13 year old young adult who was declared brain dead after a simple tonsillectomy turned tragic. Jahi has been on life support since the surgical complication occurred in early December 2013.

A trial court has ruled that the hospital may remove life support over the objection of the family since Jahi was declared brain dead by the hospital's medical and neurological staff. On the other hand, as the news outlets report, Jahi's parents are arguing that cardiac death should be used as the standard for declaration of death.

The re-definition of when *death* occurs has been debated for years. Traditionally cessation of spontaneous respiratory and cardiac function was used as the only standard for defining death.

Brain death, as a standard for declaration of death, found footing in mid-twentieth century when the techniques for transplantation of organs began to be "routine" rather than experimental. The use of extraordinary medical interventions such as intubation and artificial respiration and other means were introduced to keep the human body vital so that transplantable organs could be kept healthy, to be harvested as needed.



There are two concepts of brain death: one defines brain death as *loss of higher brain function*; and the other defines it as *whole brain death*. A Presidential Commission issued a report in the early 1980's that sided with *whole brain death* as the preferred standard for determining death. At the same time it allowed cardiac death or the irreversible cessation of circulatory and respiratory function to remain as a viable definition of death under the Uniform Determination of Death Act (UDDA).

Enacted in 1981, the UDDA defined *whole brain death* as irreversible cessation of all functions of the entire brain, including the brain stem. Therefore only artificial function can keep the body vital since the brain stem is no longer functioning.

This is all very interesting in the abstract, but very difficult in the application to individual cases. Death and dying are still mysteries that cause pain among spouses, parents, friends and family and the medical and legal profession. From Charminade's Brother Joseph Fox, to Karen Ann Quinlan, to Terry Schaivo, and now Jahi McMath, the debate over who makes the decision to remove life support rages on in hospital ethics committees; among medical and neurological staff; in churches; and in courtrooms.

What does this discussion have to do with *It's the Law*? When the time comes to put your estate portfolio is in order, you will need a health care proxy. In naming someone your proxy you need to face the issues of artificial means for the maintenance of life, including intubation and artificial nutrition and hydration. Your conversations must be candid and thorough so that your desires are carried out after you are unable to make the decisions yourself. What you want or don't want should be clearly and definitively stated.

So when you come to your lawyer to discuss Living Wills, Health Care Proxies, and other estate planning matters make sure you name people you trust as decision makers and who know your end of life wants and desires.

Jahi and her parents are in a different position. Jahi's parents and other parents like them in a like position will need great strength to make correct decisions without the guidance of a health care proxy. We all hope they find peace in the decision they will make.

The Mouth: A Mirror of Health

The mouth is often called the body's "barometer" or "mirror" of health, because it's so easy to observe and because so many diseases have oral signs and symptoms.

Many diseases can manifest themselves in the mouth and tongue. That's why when we examine your mouth, we look for more than tooth decay. Disorders that can show up in the mouth include:

- Vitamin deficiencies. A burning or sore tongue is a common symptom of iron, folic acid and vitamin B12 deficiencies. Bleeding gums can be a warning sign not only of gum disease, but also of scurvy, a Vitamin C deficiency.
- Diabetes. Early signs can include red, swollen gums and teeth that are sensitive to tapping.
- Leukemia. Signs can include sores inside the cheek, in the throat and on the tonsils and lips.
- Bulimia. The compulsive pattern of consuming enormous quantities of food and then vomiting

may lead to loss of enamel and dentin on the inner (tongue) sides of the teeth.

- Infectious mononucleosis. This condition is sometimes signaled by inflamed gums and tiny hemorrhage spots on the roof of the mouth.
- Sinusitis. This condition is an inflammation of the sinus cavity, which can feel like a toothache.
